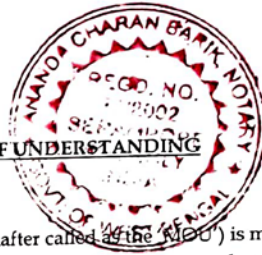

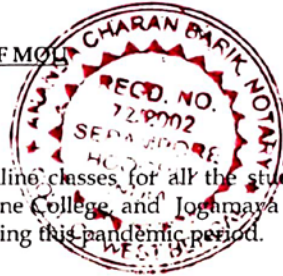

Objective of MOU

- (ii) The classes are being taken regularly from Monday to Saturday.
- (iii) The classes are being taken from 6pm to 8pm.
- (iv) The notifications regarding the classes are given at the E-Pathsala Facebook Page and at the respective colleges website.
- (v) The classes cover the syllabus for UG Semester III to VI.
- (vi) The Batch size range from 80 - 250 students.



(vii) Approximately 250 classes were already taken from Aug2020 to July 2021 through online.

(viii) Besides teaching, the E-Pathsala also involves its students in different cultural programmes, which help them to think about new ideas and also help them build up their own imagination skills. So, E-Pathsala helps in an allround development of a student.

Clause 1

CO-OPERATION

- 1.1 All the parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations. The parties shall keep each other informed of potential opportunities and share all information that may be relevant to secure additional opportunities for one another.
- 1.2 The co-operation between First Party and Second Party and third party will facilitate effective utilization of the intellectual capabilities of the all Party providing significant inputs to them in developing suitable teaching/ training systems, keeping in mind the needs of the First Party.

Clause 2

VALIDITY

2.1 The validity of the agreement is effective from the date of signature by the duly authorized representatives of the three colleges. one year from the date of agreement and shall be renewed thereafter.



2.2 The agreement may be revised with the consent of all the parties. In the event of termination, all parties mentioned in the above schedule have to discharge their obligations properly.

2.3 If any dispute or difference that may arise out of the terms and conditions of this agreement, shall be settled amicably through discussion or negotiation by the Head of three institution. If any of the party want to discontinue, then minimum 60 days prior notice in writing to be served to the rest of the parties stating reason thereof.

2.4 This agreement is executed in English Language only.

2.5 Neither party will have any financial liability in executing the terms and conditions as laid down in the agreement.
