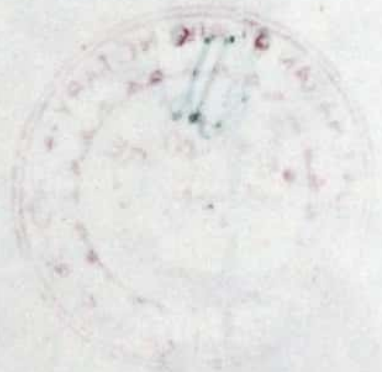

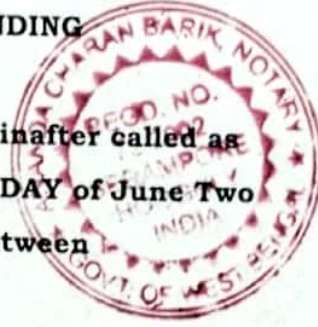

2.2 The Second Party will give valuable inputs to the First Party in training methodology so that the students can learn Basic & Advance Beautician Course.

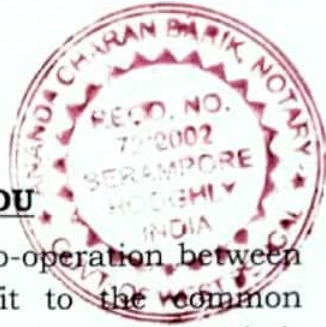
