Article 3

Article 4

LOCATION OF ACTIVITIES

- 1. The Parties agree to implement the programmes stated in Article 2 at Asutosh College and Raja Peary Mohan College.
- 2. Any changes of the location of the programmes shall be mutually agreed upon by the Parties.
