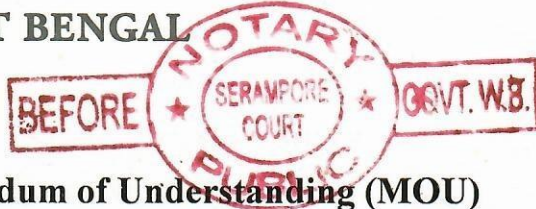

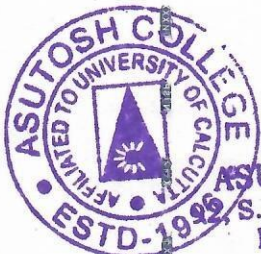

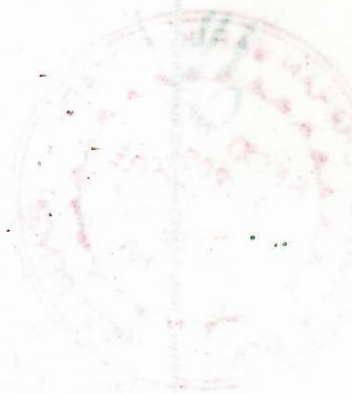

Article 1

OBJECTIVE OF COLLABORATION

The objective of this Memorandum of Understanding (MOU) is to collaborate with each other in educational projects in areas of mutual interest.

Article 2

SCOPE OF COLLABORATION

The Parties agree to implement collaborative programmes including but not limited to:

- a. Online/offline sharing of innovative ideas in Teaching – Learning and e- Governance;
- b. Faculty and student mobility.
- c. Organizing seminars / webinars / conferences / symposia through blended mode (online and offline).
- d. Sharing of scientific information on areas of mutual interest.
- e. Sharing of resources (online and reading room facilities of the library; laboratory).
- f. Undertaking Joint Research Programmes where possible.
- g. Academic quality-based collaboration, including publications and internships.

Article 3

FINANCIAL ARRANGEMENT

Involvement of funds, if required under this Memorandum of Understanding, will be subjected to approval of relevant authority/authorities.

Article 4

LOCATION OF ACTIVITIES

1. The Parties agree to implement the programmes stated in Article 2 at Asutosh College and Raja Peary Mohan College.
2. Any changes of the location of the programmes shall be mutually agreed upon by the Parties.

Article 5

MODE OF CONDUCTING THE PROGRAMMES

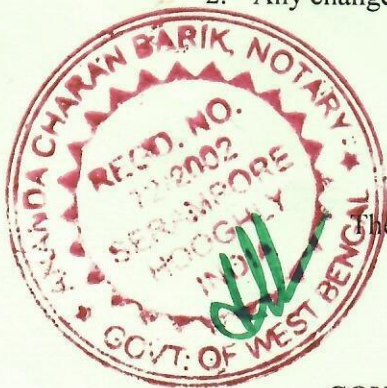
The programmes will be conducted in blended mode (offline and online).

Article 6

Article 7

DURATION AND TERMINATION

1. This MOU shall enter into force on the date of signing.
2. The MOU shall remain in force for a period of five (5) years and may be extended for another period of five (5) years by the mutual written consent of the Parties.
3. Either Party may terminate this MOU at any time by giving written notice to the other Party on its intention to terminate this MOU, at least six (6) months prior to the date of the termination.
4. The termination of this MOU shall not affect the completion of any projects and programme/s in progress and not completed at the time of termination.



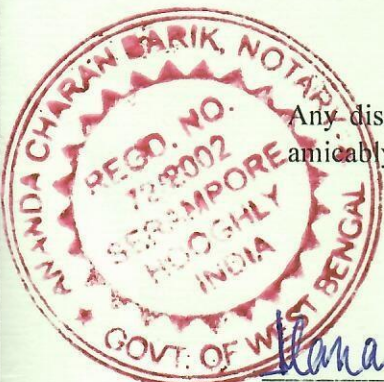
Article 8

2. Such amendment/s or revision/s shall come into force on the date as may be determined by the Parties.

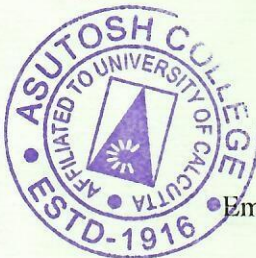
Article 9 SETTLEMENT OF DISPUTES
