Both these Institutions will be hereafter referred to as Parties.

II. PURPOSE OF THE AGREEMENT

Both the Parties are pleased to enter upon an agreement to establish ties of academic cooperation in order to contribute to the achievement of their overall goals as Institutions through the following but not limited to activities:

III. EXECUTION OF AGREEMENT

The specific activities to be carried out under this agreement will be stated in corresponding specific sub-agreements. Such specific sub-agreements, once approved by both Parties, will be attached as annexes to this agreement.

IV. TERMS AND EXPIRATION OF THE AGREEMENT

It is understood that this agreement will come into effect after being signed by both Parties and will be established for a period of 5 (five) years. Attachese five years it will be automatically affect the terms of activities ongoing at the time of notification of amendment, termination or expiration, unless otherwise agreed upon between the Parties.

Any additions, changes, deletions to this document must be approved by the representatives of both Parties. All notices shall be in writing and shall be directed to these representatives.

Any of the two Parties can choose to terminate the linkage at any time with a prior written notice of 6 (six) months.

V. NON-EXCLUSIVITY

This agreement is a non-exclusive agreement, and both Parties remain free to enter into similar agreements with third parties.

VI. SPECIAL PROVISIONS

Each Party will take approval from the other Party in writing prior to using the latter same and logo for the activities hereunder on a case-by-case basis.

All parties hereto shall do their utmost to ensure the smooth and efficient implementation of the programs.
